

Roads Update

Spring is officially here although it may not feel like it with numerous snow events and record low temperatures over the past several weeks. We'll warm up soon and with that will come the opportunity to perform roads maintenance. Here's what we have planned:

Road Base

The Board has approved applying road base to priority areas of Juniper Road and Circle Drive just like the improvements made last Fall to Upper Ranch Drive, Rock Creek Road, and Upper Stallion Drive.

- This work will be accomplished within the next month or two by our roads contractor, depending on availability of materials.
- A notice with alternative routes will be sent out to residents when work commences.
- Road closures, if necessary, will only last a few hours so your cooperation and patience is greatly appreciated while the road base is being applied and graded.



Ongoing Road Maintenance

You've likely observed spot grading in strategic areas around the Ranch to remedy the development of corrugation and potholes as they develop. This year-round maintenance approach will rectify minor roads issues before they become major roads issues, ultimately saving time, energy, and money.

Our old paradigm of roads maintenance consisted of bi-annual grading utilizing an industrial road grader at a fairly high cost. While initially effective, the results of this grading were often short lived with our decomposed granite roads often falling back into disrepair after a few short weeks. Further compounding this problem is the loss of road surface material over time, resulting in the exposure of large sections of bedrock which cannot be graded, hence the need to re-build these road surfaces.

Road base, when applied properly, will hold up much better to weather and traffic than decomposed granite and is much easier to grade. I think anyone who has driven Upper Ranch Drive since we added road base last Fall will agree the addition of this material has improved the road surface tremendously and was money well spent. I think we're moving in the right direction with a year-round maintenance program that will ensure roads are consistently evaluated and improved.

Culverts



Spring rains are right around the corner and with those afternoon thunderstorms comes a lot of water on our roadways and in our ditches. Under the influence of gravity, water will always take the path of least resistance, be it through a clean culvert or around it in the event it's blocked. Clogged culverts are one of the leading causes of road deterioration in our community. Luckily this is preventable with a little bit of shovel work on a nice day.

Driveway culvert maintenance is the resident's responsibility. Please take some time to ensure your culvert is not blocked, clogged or damaged and water can easily flow through it. Installing small 'check dams' above

culverts will help capture sediment and debris and keep your culvert clean. The Board has a nifty culvert cleaning tool that residents can use to help clean out a clogged culvert. Unable or unsure what to do? Please contact me and I'll be happy to assist!

Please note that road damage resulting from an improperly maintained driveway culvert

may be repaired by the Board and associated costs billed to the resident, so please take some time to ensure your culvert is in good working order.

Some driveways in our community don't have culverts which also directly results in road and adjacent property deterioration following large rain events. The Board is taking notice of these driveways and will be proactively contacting residents to discuss options for affordable culvert installation.

Speed Limit

A negative consequence of improving our road surfaces is the tendency for residents, guests, and service vehicles to drive at much higher speeds because it's simply possible and comfortable to do so. But that certainly doesn't mean we should drive faster just because we can.



Our speed limit is **15 mph** on all our roads and for very good reason. Why? Because maintaining good road conditions depends on lower speeds. The formation or corrugation, ruts, and potholes happens as result of vehicle speed (tires skipping versus rolling over aggregate) and aggressive acceleration and braking.

Every driver, like it or not, is responsible for maintaining our roads so **please slow down** and protect our investment!

As we head into the spring and summer season, I hope everyone will continue on with the tremendous level of mitigation efforts we saw last year. All effort will pay huge dividends if we should have a serious wildfire in our community.

Chipping Program

I hope everyone that wants slash chipping done this year is able to sign up with the Elk Creek Fire District before they close after 300 sign-ups. Sign up here.

If you have slash leftover from last year and you were on the list of addresses by last September 26th, your slash will have priority this year as they finish up from last year.

In walking around in the neighborhood, I've seen slash piles that are not compliant with the Elk Creek Fire chipping guidelines. If your pile is not compliant, it is very likely it will be not be chipped. Please review the guidelines below (also on the Elk Creek Fire District

website) and assess your slash pile.

Materials Guidelines

- Accepted materials include trees, logs and branches up to 12 inches in diameter, free of nails and wire.
- The following restrictions apply:
 - No construction or building materials, treated lumber, fence posts or signs.
 - New home construction sites are not eligible for this program.
 - No firewood stacks.
 - No shrubs, root wads, stumps, dirt or rocks. These items clog and damage chipping equipment.
 - No grass clippings, trash, weeds, bags of leaves or raked needles.

Pile Guidelines

- Piles must be stacked by 8 a.m. on the scheduled chipping day.
- Chipping will take place Monday through Friday.
- Improperly stacked piles, and any piles stacked after 8 a.m, may not be identified or collected.
- Stack piles neatly (no bags), with the large ends of branches facing the road.
- Place piles within 5 feet of the roadway, but not touching the road or in drainage ditches.
- Maximum pile size is 5 'x 5' x 5'. There is a 15-pile limit per address for each sign up period.
- After crews have removed your pile, clear away any remaining branches, needles and debris.
- Do not combine piles with neighbors' piles or place piles in other neighborhoods.
- No piles are allowed that have been created by any machinery.

Colorado State Forest Grant

We are working with Elk Creek Fire District to obtain Colorado State Forest grant money to help offset the costs of fuels mitigation on private residence property. The level of matching funds is not determined at this time.

Any resident wishing to participate would:

- 1. need to have a home assessment performed, and
- 2. mitigation work would have to be performed by a licensed contractor.

Just like with the Broadband Initiative, we will be competing with other areas across Colorado for these grant funds. Thank you to all that responded to the interest survey, so far, which we need to demonstrate interest in the grant program.

Some guidelines for your letters:

Address your letter as follows:

- Send your letter in Word or PDF format.
- Make it personal.
 - Who is your internet provider now?
 - What problems are you experiencing? How is it impacting you?
 - What are your speeds?
 - What would you like to do that you can't (for example streaming, gaming, home security cameras, manage large file downloads, teleconferencing, cellphone service boosting, etc.)?
 - Does poor internet impact your healthcare/telemedicine, your child's education, work, teleconferencing, etc?
 - How would better internet change your lifestyle?
- If you have a business, please write a letter from your business. Letters from businesses and municipalities have a lot of weight.
- Talking about property value is **NOT** the message they want to hear.
- Include the name of our neighborhood and your address.
- If you want ideas, you can look at some of the <u>grant applications</u>, <u>https://www.colorado.gov/pacific/dora-broadband-fund/apps-received</u>, that have been submitted. For example, the January 2020 Burland Grant has 70 letters.
